



TERMS AND CONDITIONS OF ENTRY – Win free GreenPower for your home for a year

1. Information on how to enter and prize details form part of these Conditions of Entry. Participation in the competition implies acceptance of the full conditions of entry.
2. Entry is open to Australian residents of domestic households, other than employees & their immediate families of the Promoter, & its related companies & agencies associated with this promotion (each an "Eligible Entrant"). "Immediate family" means spouse, defacto spouse, parent, natural or adopted child, & sibling (whether natural, or adopted by a parent), whether or not they live in the same household as the employee.
