DISCUSSION AND CONCLUSION

Results of our attended noise surveys confirm that noise emissions from the Tangaratta site are compliant with the criteria during the evening and night at the Rosebank residence. Accurate results during the day were difficult to obtain due to the high incidence of extraneous noise (i.e. birds), although observations and measured L90 noise levels do imply that the Leq day noise levels from the plant are also compliant during this period.
